Structure, Governance and Management

Governing Document

The Charity is constituted by its governing document Trust Deed dated 15 November 2007.

Trustees are appointed by existing Trustees.

The Charity was set up to support long-term research on elephants in the Okavango Delta Botswana; however it is not restricted to supported work in this area and hopes to expand its area of support.

We work closely with the Bristol University as this is where our principal researcher, Dr Kate Evans, is an Honorary Member and we have a PhD student and Masters student working under the umbrella of the Charity's research project who are registered at Bristol University and being co-supervised by Dr Kate Evans.

In addition we work closely with the University of Botswana's Harry Oppenheimer Okavango Research Centre (HOORC).

Objectives and Activities

The charitable objectives of the Charity are the advancement of education and research for the benefit of the public in the conservation and protection and monitoring of elephants:

- To monitor the demographics, ecology, behaviour, communication and movement of the elephants in Africa;
- Investigate the behaviour of male elephants and the viability of releasing captive elephants into the wild;
- Undertake a study on the parasites and diseases of the elephant population;
- Mobilize expertise and resources to assist in the enhancement of skills in the beneficiaries in the form of a scholarship fund for postgraduate degrees and supply of information;
- Identify opportunities and promoting co-operation and co-ordination between beneficiaries and other institutions or persons;
- Facilitate communication, co-operation and relationship building amongst all role players, including governments and private sector institutions, on the levels of education, strategy, policy, resources and structures;
- Conduct policy research and analysis, conservation education, facilitate technical co-operation arrangements between beneficiaries and external parties;
- Promote exchange of ideas and communication between beneficiaries and external parties;
- Organise workshops, joint working meetings and consultations between beneficiaries and other parties;
- Facilitate the exchange of information on elephant research projects.

Summary of the main activities in relation to these objects:

We support a long-term monitoring project on the elephants utilising WMA NG26 in the Okavango Delta, Botswana. Daily sightings as well as monthly road surveys help us to monitor the demographics, ecology and behaviour of the African Elephant. Our PhD student, Mr Graham Bowles, is carrying out research on the communication of the African elephants. We currently monitor five satellite collared elephants that have been released from captivity. The collars we use give us daily readings on their location, and therefore movement, through satellite downloads.

A behavioural study on male elephants has been conducted in the area since our trustee, Dr Kate Evans, started her PhD in 2002. This project was supported by Randall Moore and it was the desire to keep this project going and expand our work which gave rise to the Charity. Since 2002, six elephants have been released from a captive herd utilised in the elephant back safari industry and owned by Elephant Back Safari's Pty (Ltd). These have been 3 adolescent male elephants, 1 adult female, 1 adult male and a juvenile male. All were fitted with satellite radio collars upon release and monitored. Their movements, behaviour and interactions with the wild help us understand the viability of releasing captive elephants into the wild and their rehabilitation, but also the pro's and con's of translocation of wild animals.

Monitoring of the parasites of male elephants in the area continues, with the collection of dung samples.

In 2007-2008 we interviewed numerous potential personnel to be awarded the Boyce-Zero Scholarship Fund. In March 2008, Mphoeng Ofithile joined our research team and has been trained in the field to undertake the research. In September 2009 he officially started the fieldwork portion of -his Masters degree through the University of Bristol.

In January 2009, Dr Kate Evans visited the Save The Elephants research camp in Samburu, Kenya. There she met with Dr Iain Douglas-Hamilton the founder of Save The Elephants to discuss the future direction of the research and possible collaboration. In addition she met with their researchers and learned about the work they are doing.

Dr Kate Evans is working alongside the Conservation Research Center in America on the hormone project and liaising with Dr Eric Morgan of Bristol University to analysis the parasite samples.

Quarterly reports are produced by the research team and submitted to the Botswana Department of Wildlife and National Parks (DWNP). In addition any thesis, papers and articles produced by the research team are submitted to the Ministry of Wildlife, Environment and Tourism, the Botswana National Library Services, Botswana National Archives, Office of the President, University of Botswana Library and the Botswana Research and Development Office.

The research being undertaken is in conjunction with the Botswana's Government policy on elephant research priorities. The data we collect is used by the DWNP to make conservation and management decisions and the Botswana Tourism board often refer to it.

Dr Kate Evans and the research team are very open about the work that they do and attend international and national conferences to present on their work and network with other researchers. Dr Evans's visit to Save The Elephant shows our openness to exchange ideas and communicate with beneficiaries and external parties.

We are slowly building our network of volunteers, who assist us at events, such as the Bristol Festival of Nature; fundraise on our behalf; help promote our work; sell our merchandise and volunteer their time to help with accounts, proof reading, run our website and PR.

Public Benefit Reporting Requirement

The Trustees of Elephants for Africa have complied with section 4 of the Charities Act 2006 to have due regard to the public benefit guidance published by the Commission.

The sections in this report headed 'Objectives and Activities' and 'Achievements and Performance' give details of the activities undertaken to fulfil the Charity's objectives during the period.

Achievements and Performance

Summary of the main achievements of the charity during the period were:

- · Educational talks were given to clients visiting Seba and Abu camps in the Okavango Delta, Botswana
- · Continuation of field data gathering of PhD on vocalisation of the African elephant by Graham Bowles
- Evans, K. African elephant conservation and the role of males; the forgotten sex. Edinburgh Veterinary College. 5th March 2009
- Africa Geographic commissioned a feature for their June edition.
- Stall at Bristol Festival of Nature in June selling merchandise and adoptions.
- In September, Simon Buckingham joined the EfA team as Operations Manager
- In September, Boyce-Zero Scholarship student, Mphoeng Ofithile, began gathering field data for this MSc through Bristol University entitled 'Effects of season on the ecology and sociality of the Male elephants of the Okavango Delta, Botswana'
- 27-30th September 2009 Dr Kate Evans assisted Dr Petri Viljoen on an aerial survey of WMANG25 and WMANG26. A total of 1543 elephants were sighted in WMANG26 and 497 in WMANG25. In addition evidence of 16 dead elephants were sighted in WMANG26.
- On the 28th September the released elephants, Mafunyane and Thando were re-collared with African Wildlife Tracking satellite collars. Evans, K (2009) Paper at the Elephant Managers Association Conference in Houston, Texas entitled 'Understanding the Spatial Distribution, Abundance, Structure, Age and Sex-specific Movements of a Species for Wildlife Conservation and Management'
- Whilst in America, Buckingham and Evans also visited Chicago Zoological Society, one of our sponsors, and gave a talk to the zoo staff.
 They also visited Columbus Zoo and Aquarium another of our sponsors and gave a talk to their Conservation Committee and another to their Zoo staff. Finally they visited Rosamund Gifford Zoo in Syracuse to meet their staff and talk about possible funding ventures.
- 1st November both Kate Evans and Simon Buckingham ran their 1st ever marathon, the NYC marathon, as a fundraiser for the Charity, and completed it in 4:53:52.
- Nandipa gave birth to a healthy male calf born towards the beginning of December.

Financial Review

Details of Total Incoming Resources and Total Resources Expended are given in the Statement of Financial Activities on page 5 of the report. The Principal Funding Sources are summarised in note 2 on page 7 of the Financial Statements.

Reserves Policy

1. ACCOUNTING POLICIES

Basis of Accounting

These Financial Statements have been prepared under the historical cost convention, and in accordance with the Recommended Practice (SORP) "Accounting and Reporting by Charities" published in March 2005.

Incoming Resources

Incoming resources including Capital Grants for the purchase of fixed assets are included in full in the Statement of Financial Activities when these are receivable.

Incoming resources in the form of donated assets are included in the Statement of Financial Activities, and capitalised where appropriate at a reasonable estimate of their value.

Resources Expended

Resources expended are included in the Statement of Financial Activities on an accruals basis, inclusive of any VAT which cannot be recovered.

Direct Charitable Expenditure comprise those costs directly attributable to direct charitable activities and support costs.

Governance costs comprise all costs involving public accountability of the Charity and its compliance with regulations and good practice. These costs include independent examination fees and accountancy fees.

Tangible Fixed Assets

Depreciation is provided at the following rates in order to write off each asset over its estimated useful life:

Equipment - restricted 20% on cost - unrestricted 20% on cost Office and Computer Equipment 20% on cost

Fund Accounting

The financial statements of a charity must differentiate between restricted and unrestricted funds.

- Unrestricted funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity.
- Restricted funds are funds subject to specific conditions, imposed by the donor or by the specific terms of the charity appeal less amounts expended for these purposes.
